SPECIFICATIONS ON INVITATION FOR BID FOR: **ROTATION VEHICLE TOWING**1.0 **INTENT:**

It is the intent of Maricopa County to enter into a rotation system that will provide required towing and towing related services in response to requests from the Maricopa County Sheriff's Office. This agreement is to provide standardized, fair and reasonable services and pricing for towing requested by the Maricopa County Sheriff's Office.

2.0 **TECHNICAL SPECIFICATIONS:**2.1 **DEFINITION OF TERMS:**

- 2.1.1 After hours - Responding to storage lot to release vehicle after the company's normal business hours.
- 2.1.2 Call-out/Hook-up - The response of the towing company to a request for service from the Sheriff's Office. Includes the act of hooking up the item to be towed, cleaning up the debris, and the labor involved.
- 2.1.3 Clean up - A charge by the company to sweep up any debris remaining at an accident scene or any hazardous material at a scene which is required by law. This duty is part of the call-out/hook-up charge.
- 2.1.4 Daily storage - The daily charge incurred for storing a vehicle to begin 24 hours after it was towed.
- 2.1.5 Dollie - An independent wheeled platform used to transport a disabled vehicle.
- 2.1.6 Driveline - The removal of the driveline to prevent additional damage to the vehicle and to facilitate the tow.
- 2.1.7 Labor - A labor charge for the energy expended by the employee for the act of towing an item. This duty is part of the call-out/hook-up charge.
- 2.1.8 Non-Vehicle - Any device or object not primarily used for transportation.
- 2.1.9 Off Road Recovery - A charge applied when the towing company must leave the normal public roadway to recover a vehicle from a desert area, farm field, ditch, or ravine.
- 2.1.10 Water Recovery - A charge applied when the towing company employee must enter water past the knees in order to effect a recovery, or when the vehicle is totally submerged in water.
- 2.1.11 Stand by - A charge by the company which is applied after arriving on scene of a requested tow and not being allowed to begin service for a period of at least fifteen minutes.
- 2.1.12 Towing Area - One of the subdivisions into which Maricopa County has been broken down to provide boundaries for rotation towing services. See Attachment A for a list of Towing Area boundaries and a map of the Towing Areas.
- 2.1.13 Towing Area List - A rotation list of Towing Companies to perform towing services in a specific Towing Area.
- 2.1.14 Towing Company - A legal entity, which provides towing, and towing related services. All employees, owners, and shareholders of a Towing Company shall be considered as being part of a Towing Company and therefore will be referred to forthwith as a "Contractor."
- 2.1.15 Towing mileage - A charge applied when the towing company must tow an item from the scene to the designated destination.
- 2.1.16 Towing Services Coordinator - The designated representative of the Maricopa County Sheriff's Office who serves as the liaison between a Towing Company and the Maricopa County Sheriff's Office.
- 2.1.17 Tow Vehicle - Any device, motorized or otherwise, which a Towing Company uses to provide towing or towing related services.
- 2.1.18 Vehicle - Any device or object whose use or intended use is, or was, for transportation.
- 2.1.19 Wincing - A charge applied by the towing company for utilizing their winch to recover an item in a location not accessible by vehicle. The charge **may be assessed only when** a vehicle must be uprighted, or when more than 75 feet of cable is used.

2.2 PROCEDURAL REQUIREMENTS:

- 2.2.1 Prior to requesting a position on a Towing Area List, Towing Companies must have all Tow Vehicles it intends to use certified by the Arizona Department of Public Safety and must be able to show proof of that certification upon demand.
- 2.2.2 When a Towing Company is offered a position on a Towing Area List they shall forward a copy of their current insurance certificates to the Towing Services Coordinator in compliance with this agreement. The insurance certificate must contain the insurance company name, address, and phone number. It must also contain the name of the Towing Company, policy number, and effective and expiration dates. Prior to an insurance policy expiring, a copy of the renewal certificate must be forwarded to the Towing Services Coordinator.
- 2.2.3 Tow Vehicles being considered for use by a Towing Company for services under the agreement will be registered and licensed in the Towing Company or ownership name. The only exception will be a leased Tow Vehicle in which case a copy of the current lease agreement will be furnished to the Towing Services Coordinator. Except as provided herein, the use of unregistered, unlicensed, or uncertified Tow Vehicles is prohibited.
- 2.2.4 A Towing Company shall be allowed only one (1) position on each Towing Area List. The Towing Company must maintain and store vehicles towed under the agreement in an Maricopa County Sheriff's Office approved storage lot within the Towing Area the services were performed. The only exception is a tow performed in a Towing Area outside the Towing Company's normal Towing Area.
- 2.2.5 All Tow Vehicles must comply with State regulations pertaining to towing. Dollies, brooms, and oil absorbent materials must be carried on all Tow Vehicles responding for services under the agreement.
- 2.2.6 Towing Companies responding to calls for service under the agreement will have the necessary equipment and knowledge to effectively handle any abandoned vehicle or accident recovery work. Towing Companies will be advised by the Sheriff's Office at the time of dispatch if any special equipment, extra Tow Vehicles, or extra personnel are required for the call. The towing company will be responsible for their decision on what equipment to send. **The Towing Company shall only charge for the equipment necessary to perform the tow.** Failure to observe the provisions of this section will result, **at a minimum** in the Towing Company losing the tow and being placed on the bottom of the Towing Area List rotation. **The County reserves the right to exercise any and all other remedies provided in this agreement.**
- 2.2.7 Rates charged by a Towing Company for services under the agreement shall not be in excess of those authorized per Attachment A.
- 2.2.8 All vehicles towed under the conditions of the agreement will be stored in a locked, enclosed storage area that has been approved by the Towing Services Coordinator, or his designee. (Unless, **in the case of vehicles that are not seized or impounded** the **vehicle owner** requests that the item be towed to a specific location) A six foot (6') chain link, or better, type fence will be in place around the storage location. Access to the storage areas must be available to representatives of the Sheriff's Office twenty-four (24) hours a day, 365 days a year. Storage areas will be inspected by the Towing Services Coordinator, or his designee, prior to the initial awarding of an agreement and periodically during the duration of the agreement.
- 2.2.9 Towing Companies on the rotation list for the Maricopa County Sheriff's Office must be available for calls twenty-four (24) hours a day, 365 days a year.
- 2.2.10 If no Towing Companies are available for service in a particular Towing Area or if the service is **significantly** closer to another list Towing Company, a Towing Company from an adjoining Towing Area may be requested to respond. The tow would be treated as if it had occurred in the **utilized** Towing Company's agreed upon Towing Area.
- 2.2.11 Under unusual circumstances Towing Companies may be requested to move, or remove, Non-Vehicles from a location. Fees for these services will be dependent on the equipment used.
- 2.2.12 Each Towing Company approved for the rotation list will be furnished with an alpha-numeric designation decal for each of its Tow Vehicles. The decal will denote the Towing Area List rotation number of the Towing Company. The decal must remain legible and shall not be altered or defaced in any manner. Should the decal become illegible, the Towing Company must contact the Towing Services Coordinator and request a new decal. In all cases the alphanumeric decal remains the property of the Maricopa County Sheriff's Office and will be returned to the Towing Services Coordinator when a Tow Vehicle is put out of service or when a Towing Company loses a position.

- 2.2.13 A decal will be permanently affixed to each Towing Company Tow Vehicle being used for services under the agreement. The placement of the decal is to be on the left (driver's) side of the Tow Vehicle in a position forward of the driver's door and not more than eight inches (8") below the top of the hood and not more than eight inches (8") forward of the driver's door. The decal shall be placed such that it is completely visible when a person is facing the left side of the Tow Vehicle.
- 2.2.14 When a request is made to a Towing Company the deputy requesting the service will be advised of the alphanumeric designator and name of the Towing Company responding. The Tow Vehicle responding to the location must bear the name, address, and phone number of the Towing Company in addition to the correct alphanumeric designator in order to be eligible for the tow. Any Tow Vehicle arriving at the location not bearing the correct alphanumeric designator will not be permitted to tow. This is regardless of whether the Tow Vehicle belongs to the same Towing Company from which services were requested. Under these circumstances the Towing Company will lose the tow and move to the bottom of the Towing Area List rotation.
- 2.2.15 Any Towing Company that is requested to respond for a tow must acknowledge their acceptance of the call immediately. If contact is made with an answering machine, the Towing Company will lose the tow and be placed on the bottom of the Towing Area List rotation.
- 2.2.16 In any instance, when a Towing Company is unable to be contacted, fails to respond after acknowledging a call, or is unable to respond for any reason, that Towing Company will lose the tow and be placed at the bottom of the Towing Area List. If such circumstances become a reoccurring problem the Towing Company may face a suspension.
- 2.2.17 A thirty (30) minute response time will be allowed. The response time is the length of time elapsing when the Towing Company acknowledges a request for service and when the Tow Vehicle arrives on the scene of a call. If the response time exceeds thirty (30) minutes the on scene deputy will be given the option of canceling the call and requesting that another Towing Company respond. If the Tow Vehicle from the Towing Company originally requested arrives on scene after another request has been made to a different Towing Company, the original Towing Company will lose the tow and be placed on the bottom of the Towing Area List rotation.
- 2.2.18 The Towing Companies will keep the Towing Services Coordinator advised of all changes in the Towing Company. This includes, but is not limited to, a change in ownership, phone numbers, storage lot locations, and insurance companies.

2.3 GENERAL PERFORMANCE REGULATIONS:

- 2.3.1 When a Tow Vehicle arrives at a call, the driver will cooperate with the on scene deputy to the fullest extent and will honor all reasonable requests for service. If requested, the towing company will provide an estimate of the cost of services rendered, and will indicate the cost of storage.
- 2.3.2 When two (2) or more Towing Companies are called for service, the driver of the Tow Vehicle, which arrives first, will normally be given the choice of vehicles to tow. However, the final decision will be made by the on scene deputy.
- 2.3.3 All Towing Companies responding to the scene will share the responsibility for clearing the roadway after the vehicles have been removed to the roadside. This includes, but is not limited to, items such as glass and vehicle parts. Tow Vehicle drivers will not leave the scene of the call until this detail is complete.
- 2.3.4 Towing Companies shall not call the Maricopa County Sheriff's Office Communications Center, or the complaint desk, for any reason other than to verify the location of a call. All complaints, requests, or information calls will be handled by the Towing Services Coordinator.
- 2.3.5 Towing Companies will not subject MCSO employees or the public to unprofessional and/or abusive conduct.

2.4 COMPLAINTS:

- 2.4.1 All complaints made against a Towing Company, while performing services under an agreement with the Maricopa County Sheriff's Office, shall be investigated by the Towing Services Coordinator, or his designee. The Towing Company will be advised as to the outcome of the investigation and the extent of the disciplinary action to be taken, if any.
- 2.4.2 The Maricopa County Sheriff's Office will practice quality control management of towing company services by utilizing a random survey to customers utilizing the rotation list. Commendations and complaints will be sent to each towing company and a copy of each will remain in the towing company's file at the Maricopa County Sheriff's Office.

2.5 VIOLATIONS:

2.5.1 The confirmed violation of any section of these requirements and regulations will subject the offending Towing Company to possible suspension or cancellation of services. All recommendations for the suspension or cancellation of an agreement will be reviewed by the Maricopa County Sheriff's Office Planning and Research Division and the Towing Company Coordinator to assure that no arbitrary or punitive actions are being taken against a Towing Company for any unsubstantiated allegations of misconduct.

VIOLATIONS: A confirmed violation of any contract requirements shall be immediately remedied and may result in a thirty (30) day suspension off the rotation list for the towing company within the towing area in which the violation occurred. Two thirty (30) day violations within a six (6) month period is cause for permanent removal from the towing list. If a Towing Company becomes abusive with any Maricopa County Sheriff's Office personnel or the public, the Towing Company may be subjected to the immediate and permanent cancellation of all agreements. Nothing precludes the Maricopa County Sheriff's Office from the immediate and permanent removal of a towing company from the list for a serious violation of the regulations.

2.5.2 The Towing Company has the right to make an appointment with the Towing Company Coordinator for the review of the Company's file. The Towing Company's file contents will be available to representatives of that Towing Company.

3.0 SPECIAL TERMS & CONDITIONS:

3.1 DISPUTE RESOLUTION:

Protests and appeals of contract awards shall be handled in accordance with Section MCI-905 of the Maricopa County Procurement Code and contract disputes shall be handled in accordance with the provisions of Section MCI-906 of the Maricopa County Procurement Code.

3.2 PRICING:

All Towing Companies are required to accept charges per the attached pricing page. A Towing Company must accept prices for all services for each Towing area they are applying for. All prices shall include clean up of debris, all non-excessive winching, hookups, preparing to tow, and any other charge which may be incidental to any given towing situation. There shall be no additional charges made by the Towing company unless specifically set forth in this contract. All prices shall be for 24 hours a day, 365 days a year.

3.3 STORAGE LOTS:

All Towing Companies are required to provide the address of the storage lots they intend to use if awarded a position on a Towing Area List. See Attachment D for a storage lot worksheet.

3.4 BILLING:

All charges for towing and services will be the sole responsibility of the towed equipment owner. Maricopa County has no responsibility for payment for service rendered under this contract.

4.0 CONTRACT TERMS AND CONDITIONS:

4.1 AGREEMENT LENGTH:

The agreement length will be for a two (2) year period with an option to renew under the existing terms and conditions.

4.2 OPTION TO EXTEND:

The County may, at their option and with the approval of the Contractor, extend the period of this agreement up to a maximum of three (3), one (1) year options. The Contractor shall be notified in writing by the Materials Management Department of the County's intention to extend the contract period at least thirty (30) calendar days prior to the expiration of the original contract period.

4.3 ESCALATION:

Any requests for price adjustments must be submitted thirty (30) days prior to the Contract renewal date. Justification for the requested adjustment in cost of labor and/or materials must be accompanied by appropriate documentation. Escalation shall not exceed the increase in the U.S. Department of Labor (Bureau of Labor Statistics) Consumer Price Index for Urban Consumers. Increases shall be approved in writing by the Materials Management Department prior to any adjusted invoicing submitted for payment.

4.4 UNCONDITIONAL TERMINATION FOR CONVENIENCE:

Maricopa County may terminate the resultant Contract for convenience by providing sixty (60) calendar days advance notice to the Contractor.

4.5 TERMINATION FOR DEFAULT:

If the Contractor fails to meet deadlines, or fails to provide the agreed upon service/material altogether, a termination for default will be issued. The termination for default will be issued only after it is deemed by the County, that the Contractor has failed to remedy the problem after being forewarned.

4.6 TERMINATION BY THE COUNTY:

If the Contractor should be adjudged bankrupt or should make a general assignment for the benefit of its creditors, or if a receiver should be appointed on account of its insolvency, the County may terminate this Contract. If the Contractor should persistently or repeatedly refuse or should fail, except in cases for which extension of time is provided, to provide enough properly skilled workers or proper materials, or persistently disregard laws and ordinances, or not proceed with work or otherwise be guilty of, a substantial violation of any provision of this Contract, then the County may terminate this Contract. Prior to termination of this Contract, the County shall give the Contractor fifteen (15) calendar days written notice. Upon receipt of such termination notice, the Contractor shall be allowed fifteen (15) calendar days to cure such deficiencies.

4.7 APPROPRIATION CONTINGENCY:

The Contractor recognized that any agreement entered into shall commence upon the day first provided and continued in full force and effect until termination in accordance with its provisions. The Contractor and the County herein recognized that the continuation of any contract after the close of any given fiscal year of the County which fiscal years end on June 30 of each year, shall be subject to the approval of the budget of the County providing for or covering such contract item as an expenditure therein. The County does not represent that said budget item will be actually adopted, said determination being the determination of the County Board of Supervisors at the time of the adoption of the budget.

4.8 ORGANIZATION - EMPLOYMENT DISCLAIMER:

The Contract is not intended to constitute, create, give rise to or otherwise recognize a joint venture contract or relationship, partnership or formal business organization of any kind, and the rights and obligations of the parties shall be only those expressly set forth in the Contract.

The parties agree that no persons supplied by the Contractor(s) in the performance of obligations under the contract are considered to be County employees, and that no rights of County civil service, retirement or personnel rules accrue to such persons. The Contractor(s) shall have total responsibility for all salaries, wages, bonuses, retirement withholdings, workmen's compensation, other employee benefits and all taxes and premiums appurtenant thereto concerning such persons, and shall save and hold the County harmless with respect thereto.

4.9 STATUTORY RIGHT OF CANCELLATION FOR CONFLICT OF INTEREST:

Notice is given that pursuant to A.R.S. § 38-511 the County may cancel this Contract without penalty or further obligation within three years after execution of the contract, if any person significantly involved in initiating, negotiating, securing, drafting or creating the contract on behalf of the County is at any time while the Contract or any extension of the Contract is in effect, an employee or agent of any other party to the contract in any capacity or consultant to any other party of the Contract with respect to the subject matter of the Contract. Additionally, pursuant to A.R.S. § 38-511 the County may recoup any fee or commission paid or due to any person significantly involved in initiating, negotiating, securing, drafting or creating the contract on behalf of the County from any other party to the contract arising as the result of the contract.

4.10 INDEMNIFICATION:

To the fullest extent permitted by law, the Contractor shall defend, indemnify and hold harmless the County, its Agents, Representatives, Officers, Directors, Officials and Employees from and against all claims, damages, losses and expenses (including but not limited to attorney fees, court costs, and the cost of appellate proceedings), relating to, arising out of, or alleged to have resulted from the acts, errors, mistakes, omissions, work or services of the Contractor, its Employees, Agents, or any tier of Subcontractors in the performance of this Contract. Contractor's duty to defend hold harmless and indemnify the County, its agents, representatives, officers, directors, officials and employees shall arise in connection with any claim damage, loss or expense that is attributable to bodily injury, sickness, disease, death, or injury to, impairment, or destruction of property including loss of use resulting therefrom, caused by any acts, errors, mistakes, omissions, work to services in the performance of this Contract including any employee of the Contractor or any tier of subcontractor or any other person for whose acts, errors, mistakes, omissions, work or services the Contractor may be legally liable.

The amount and type of insurance coverage requirements set forth herein will in no way be construed as limiting the scope of the indemnity in this paragraph.

4.11 INSURANCE REQUIREMENTS:

General Clauses. The Contractor, at its own expense, shall purchase and maintain the minimum insurance specified below with companies duly licensed, with a current A.M. Best, Inc. Rating of B++6, or approved unlicensed by the State of Arizona Department of Insurance.

Additional Insured. The insurance coverage, except Workers' Compensation and Professional Liability, required by this Contract, shall name the County, its agents, representatives, officers, directors, officials and employees as Additional Insureds.

Coverage Term. All insurance required herein shall be maintained in full force and effect until all work or service required to be performed under the terms of the Contract is satisfactorily completed and formally accepted; failure to do so may, at the sole discretion of the County, constitute a material breach of this Contract.

Primary Coverage. The Contractor's insurance shall be primary insurance as respects the County, and any insurance or self insurance maintained by the County shall not contribute to it.

Claim Reporting. Any failure to comply with the claim reporting provisions of the policies or any breach of a policy warranty shall not affect coverage afforded under the policies to protect the County.

Waiver. The policies, except Workers' Compensation, shall contain a waiver of transfer rights of recovery (subrogation) against the County, its agents, representatives, directors, officers, and employees for any claims arising out of the Contractor's work or service.

Deductible/Retention. The policies may provide coverage which contain deductibles or self insured retentions. Such deductible and/or self insured retentions shall not be applicable with respect to the coverage provided to the County under such policies. The Contractor shall be solely responsible for the deductible and/or self insured retention.

Copies of Policies. The County reserves the right to request and to receive, within 10 working days, certified copies of any or all of the above policies and/or endorsements. The County shall not be obligated, however, to review same or to advise Contractor of any deficiencies in such policies and endorsements, and such receipt shall not relieve Contractor from, or be deemed a waiver of the County's right to insist on, strict fulfillment of Contractor's obligations under this Contract.

Garage Keepers Liability. Contractor shall maintain Garage Keepers Liability insurance with a limit of not less than \$1,000,000 for each occurrence.

Garage Keepers Legal Liability/ On Hook coverage: Contractor shall maintain such liability insurance with a limit of not less than \$100,000 Property Damage each occurrence.

Such policy shall contain a severability of interest provision, and shall not contain a sunset provision or commutation clause, nor any provision, which would serve to limit third party action over claims.

Automobile Liability. Contractor shall maintain Commercial/Business Automobile Liability insurance with a combined single limit for bodily injury and property damage of not less than \$1,000,000 each occurrence with respect to the Contractor's any owned, hired, and non-owned vehicles assigned to or used in performance of the Contractor's work or services. Coverage will be at least as broad as coverage code 1, "any auto", (Insurance Service Office, Inc. Policy Form CA 00011293, or any replacements thereof).

Workers' Compensation. The Contractor shall carry Workers' Compensation insurance to cover obligations imposed by federal and state statutes having jurisdiction of Contractor's employees engaged in the performance of the work or services; and Employer's Liability insurance of not less than \$500,000 for each accident, \$100,000 disease for each employee, and \$500,000 disease policy limit.

In case any work is subcontracted, the Contractor will require the Subcontractor to provide Worker's Compensation and Employer's Liability to at least the same extent as required of the Contractor.

Cargo Insurance: A certificate of insurance evidencing insurance coverage for cargo damage written on a comprehensive form with a liability of at least \$50,000 for damage to vehicles in tow.

4.12 CERTIFICATES OF INSURANCE:

Prior to commencing work or services under this Contract, Contractor shall furnish the County with Certificates of Insurance, or formal endorsements as required by the contract, issued by Contractor's insurer(s), as evidence that policies providing the required coverages, conditions and limits required by this Contract are in full force and effect.

In the event any insurance policy(ies) required by this Contract is(are) written on a "claims made" basis, coverage shall extend for two years past completion and acceptance of the work or services and as evidenced by annual Certificates of Insurance.

4.13 CANCELLATION AND EXPIRATION NOTICE:

Insurance evidenced by this Certificate shall not expire, be canceled, or materially changed without fifteen (15) days prior written notice to the County. If a policy does expire during the life of the Contract, a renewal Certificate must be sent to the County fifteen (15) days prior to the expiration date.

All Certificates of Insurance required by this Contract shall be identified with a Bid Serial Number and Title A \$25.00 administrative fee shall be assessed for all Certificates received without the appropriate Bid Serial Number and Title.

4.14 ADDITIONS/DELETIONS OF SERVICE:

The County reserves the right to add and/or delete services to this Contract. Should a service requirement be deleted, payment to the Contractor will be reduced proportionally, to the amount of service reduced in accordance with the bid price. Should additional services be required from this Contract, prices for such additions will be negotiated between the Contractor and the County.

4.15 SUBCONTRACTING:

The Contractor may not assign this Contract or Subcontract to another party for performance of the terms and conditions hereof without the written consent of the County. All correspondence authorizing subcontracting must reference the Bid Serial Number and identify the job project.

The Subcontractor's rate for the job shall not exceed that of the Prime Contractor's rate, as bid in the pricing section, unless the Prime Contractor is willing to absorb any higher rates. The Subcontractor's invoice shall be invoiced directly to the Prime Contractor, who in turn shall pass-through the costs to the County, without mark-up. A copy of the Subcontractor's invoice must accompany the Prime Contractor's invoice.

4.16 AMENDMENTS:

All amendments to this Contract must be in writing and signed by both parties.

4.17 CONFORMATION WITH THE LAW:

This service shall be accomplished in conformity with the laws, ordinances, rules, regulations and zoning restrictions of the United States of America, the State of Arizona, County of Maricopa, and the City of Phoenix.

4.18 CONTRACT COMPLIANCE MONITORING:

The Materials Management Department and the using Agency (ies) shall monitor the Contractors compliance with, and performance under, the terms and conditions of the Contract. The Contractor shall make available for inspection and/or copying by the County all records and accounts relating to the work performed or the services provided in this Contract.

4.19 RETENTION OF RECORDS:

The Contractor agrees to retain all financial books, records, and other documents relevant to this Contract for five (5) years after final payment or until after the resolution of any audit questions which could be more than five (5) years, whichever is longer. The Department, Federal or State auditors and any other persons duly authorized by the Department shall have full access to, and the right to examine, copy and make use of any and all said materials.

4.20 ADEQUACY OF RECORDS:

If the Contractor's books, records and other documents relevant to this Contract are not sufficient to support and document that allowable services were provided. The Contractor shall reimburse Maricopa County for the services not so adequately supported and documented.

4.21 AUDIT DISALLOWANCES:

If at any time it is determined by the Department that a cost for which payment has been made is a disallowed cost, the Department shall notify the Contractor in writing of the disallowance and the required course of action, which shall be at the option of the Department either to adjust any future claim submitted by the Contractor by the amount of the disallowance or to require repayment of the disallowed amount by the Contractor forthwith issuing a check payable to Maricopa County.

4.22 P.O. CANCELLATION LANGUAGE:

The Department of Materials Management reserves the right to cancel Purchase Orders within a reasonable period of time after issuance. Should a Purchase Order be canceled, the County agrees to reimburse the Contractor but only for actual and documentable costs incurred by the Contractor due to and after issuance of the Purchase Order. The County will not reimburse the Contractor for any costs incurred after receipt of County notice of cancellation, or for lost profits, shipment of product prior to issuance of Purchase Order, etc.

Contractors agree to accept verbal notification of cancellation from the Department of Materials Management with written notification to follow. By submitting a bid/proposal in response to this Invitation For Bids, the Contractor specifically acknowledges to be bound by this cancellation policy.

4.23 VALIDITY:

The invalidity, in whole or in part, of any provision of this Contract shall not void or affect the validity of any other provision of this Contract.

4.24 CONTRACTOR RESPONSIBILITY:

The Contractor will be responsible for any damages whatsoever to County property as applicable when such property is the responsibility or in the custody of the Contractor, his employees or Subcontractors.

4.25 GUARANTEE:

The materials and supplies called herein shall be the best of their grade and types, prepared according to the best available standards or accepted formulas, and thoroughly tested and subjected to rigid examination and standardization. Items not meeting these requirements shall be replaced at no cost to the County upon due notice of deficiency.

4.26 DELIVERY:

It shall be the Contractor responsibility to meet the County's delivery requirements, as called for in the Technical Specifications. Maricopa County reserves the right to obtain services on the open market in the event the Contractor fails to make delivery and any price differential will be charged against the Contractor.

4.27 **PRICE REDUCTIONS:**

By submitting a bid or proposal in response to this Invitation For Bids, Contractors agree to guarantee that Maricopa County is receiving the lowest price offered by your company to other customers for similar services at comparable volumes in a similar geographic area. If at any time during the Contract period your company offers a lower price to another customer, notification not be made of price reductions, upon discovery Maricopa County shall reserve the right to take any or all of the following actions:

- 4.27.1 Cancel the Contract, if it is currently in effect.
- 4.27.2 Determine the amount, which the County was overcharged and submit a request for payment from the Contractor for that amount.
- 4.27.3 Take the necessary steps to collect any performance surety provided on the applicable Contract.

4.28 **RIGHTS IN DATA:**

The County shall have the use of data and reports resulting from this Contract without additional cost or other restriction except as may be established by law or applicable regulation. Each party shall supply to the other party, upon request, any available information that is relevant to this Contract and to the performance hereunder.

4.29 **SECURITY AND PRIVACY:**

The Contractor agrees that none of its officers or employees shall use or reveal any research or statistical information furnished by any person and identifiable to any specific private person for any purpose other than the purpose for which it was obtained. Copies of such information shall not, without the consent of the person furnishing such information, be admitted as evidence or used for any purpose in any action, suit, or other judicial or administrative proceedings, unless ordered by a court of competent jurisdiction. The County shall be notified immediately upon receipt of any such order of court, pertaining to production of such information.

The Contractor shall incorporate the foregoing provisions of this paragraph in all of its authorized subcontracts.
