Case Management	Medical Case Mgmt, Supportive Case Mgmt, RN Case Mgmt, Financial Assistance processing, transitional case management (within 90 days of release)	Up to 400%	Minimum services allowed to non-eligible clients, see Section 2 Service Specific Policy.
AIDS Pharmaceutical Assistance (Financial Assistance Program) NOT FUNDED IN FY2010	Prescription medications and copays	Up to 400%	Must be processed through Case Mgmt, Medicare part D copays can not be covered, max \$3,000 per Ryan White Part A fiscal year
Oral Health Care (Financial Assistance Program) NOT FUNDED IN FY2010	Dental copays and deductibles	Up to 300%	Must be processed through Case Mgmt, no orthodontics or cosmetic in nature procedures are covered, max \$1,500 per Ryan White Part A fiscal year
Health Insurance Premium and Cost Sharing Assistance	Public or private health insurance premiums, including COBRA if danger of insurance lapsing	Up to 400%	Must be processed through Case Management. \$3000 cap. Timeframe: Until \$3000 cap is reached, or until COBRA 18 month timeframe is reached. Client may receive a total of \$3000 or a total of 18 months of assistance.
Emergency Financial Assistance (Financial Assistance Program) NOT FUNDED IN FY2010	Short term payments for emergency expenses related to essential utilities, housing, food	Up to 200%	Must be processed through Case Management, includes general assistance for housing and utilities, max \$400 per Ryan White Part A fiscal year. HOPWA financial assistance must be exhausted if applying for housing assistance.
Food Bank/Meals	Food boxes and congregate meals	Up to 300%	Maximum of 2 food boxes per month.
Legal Services	Legal Hotline, Estate Planning, Healthcare Issues, Housing Issues	Up to 300%	Legal services may not be used for: accommodation, adoption/guardianship, child custody, collections/finance, dissolution of marriage, employment discrimination, incarcerated rights, individual rights, insurance issues, or bankruptcy proceedings.
Mental Health Services	Assessments, counseling (individual, family, couples), support groups, psych evaluations, medication mgmt.	Up to 300%	Affected individuals may be served under limited as defined in Section 2 Service Specific policies.
Medical Nutrition Services	Assessments, RD nutrition counseling, nutrition supplements	Up to 300%	All services provided must be done by a Registered Dietician.
Oral Health Services	Dental insurance program	Up to 300%	No cosmetic or orthodontic procedures.
Outreach Services	Case findings, follow ups, brief contacts, presentations	N/A	Identify out of care individuals and bring them in to care. Client eligibility is not required to perform services.
Outpatient Ambulatory Health Services	Medical visits, laboratory testing, diagnostic testing, specialist services, surgery services	Up to 300%	No cosmetic in nature services
Psychosocial Support Services	Assessments, counseling, support groups, non RD nutrition counseling services	Up to 300%	
Outpatient Substance Abuse Services	Assessments, counseling (individual, family, couples), support groups, psych evaluations, medication mgmt, residential treatment	Up to 300%	
Transportation Services	public transit passes, taxi services	Up to 300%	Services available for transportation to any core or supportive service
Interpreting Services	Interpretation for client receiving an eligible service	Based upon the FPL for the service being interpreted	Maricopa County - Ryan White Part A Office provides contractors to facilitate service.

All activities performed must be directly related to the HIV-related clinical status of an eligible client and documented appropriately in the client chart

All activities performed must be delivered to eligible clients as determined in Central Eligibility, except where noted under Case Management and Outreach Services.
