#### **Where will the SEI trainings be held?**

The trainings will be held at the Maricopa County Superintendent of Schools Office, Educational Services Agency

#### **Who is the Instructor?**

Kelly Salvia, a state approved provider of SEI 45 Completion for the Full SEI Endorsement and 45 hour Augmented training.

#### **Which SEI 45 hour training is this?**

This SEI 45 hour training will satisfy the hours needed to complete the SEI 60. You must have already taken the first 15 hours for provisional endorsement in order to sign up for this training.

#### **What text(s) will be used?**

All materials will be provided to you on the first day of training (the cost of materials is included in the price).

#### **Where can I get a syllabus?**

The syllabus will be distributed on the first day of the training.

#### **How many days is the training?**

There are six days total (3 Fridays and 3 Saturdays, plus 7.5 hours of minimal homework). This will complete 45 hours of training.

#### **How do I sign up?**

### **Are there any prerequisites for the 45 hour COMPLETION training?**

For the current SEI 45 hour training, **yes**, you must have completed the 15 or 45 hour PROVISIONAL training/class before going on to the 45 hour COMPLETION of the Full Endorsement training.

### **How do I know how many hours I need to satisfy the SEI Certification?**

Please see chart below:

#### Scenario I

Persons who received a teaching certificate in Arizona prior to August 31, 2006

OR

Persons who received a teaching certificate in another state prior to August 31, 2006 and are now under a Reciprocal or Provisional AZ teaching certificate:

- Need 15 hours (or 1 credit class) for an SEI provisional and should have already added it. Anyone who has not done so, needs to do so as soon as possible. (R7-2-613. J.2.c)
- Once the provisional has been added, the participant has 3 years to complete the full endorsement (additional 45 hours or 3 credit course).

#### Scenario II

Persons who receive a teaching certificate in Arizona after August 31, 2006

OR

Persons who receive a teaching certificate in another state after August 31, 2006 and are now under a Reciprocal or Provisional AZ teaching certificate:

- Need 45 hours (or 3 credit course) for an augmented SEI provisional. (R7-2-613.J.1)
- Need to add the provisional to their AZ State Certificate within one year of initial certification. (A.A.C.R7-2-619)
- Once the provisional is added, the participant has 3 years to complete the full endorsements. (additional 45 hours or 3 credit course).

### **Will I receive college credit?**
