Five things to remember.

1. Use the myCigna® App or website.

24/7 access to all you need to know about your coverage.

2. Use “Price a Medication.”

Prescription prices can vary by pharmacy. Before you fill your prescription, compare your costs online. Log in to the **myCigna** app or website and click on “Price a Medication” to find out how much your medication will cost you at the different pharmacies in your network. You can also see if there are lower-cost alternatives available.²

3. Choose generics and save.

Generics typically cost much less than brand-name medications – in some cases, up to 85% less.³ They have the same active ingredients, strength and dosage form as the brand-name medication. Just because generics cost less than brands, it doesn't mean they're lower-quality medications.

4. Use Cigna Home Delivery Pharmacy.¹

- › Free standard delivery to your home or work address within the United States.
- › Fill up to a 90-day supply at one time, so you fill less often.
- › Free refill reminders by email to help make sure you don't miss a dose.
- › Refill your medication and track your orders on the myCigna app or website.
- › 24/7 access to licensed pharmacists.
