SPECIFICATIONS ON INVITATION FOR BID FOR: **ADVERTISING SERVICES****1.0 INTENT:**

1.1 PURPOSE

The purpose of this Invitation for Bids is to establish a contract for Advertising Services for Maricopa County, on an as needed basis. The county is interested in agencies capable of providing local, state and national coverage.

1.2 SCOPE

This document defines the basic services required, the bid procedures and the evaluation and award criteria, and other factors pertinent to this bid.

1.3 CONTRACT AWARD CRITERIA

It is the intent of Maricopa County to procure the services of the most qualified firm(s). The contract will be awarded to all vendors who are found responsive and responsible.

1.4 MULTIPLE AWARDS:

In order to ensure adequate coverage of the requirements of various using agencies throughout Maricopa County, multiple awards will be made. The County also reserves the right to add vendors to the contract during the contract period, to meet its ongoing requirements and to best meet its needs.

2.0 TECHNICAL SPECIFICATIONS:

2.1 CATEGORIES OF SERVICE:

This requirements contract will be used to provide Advertising Services for various Maricopa County Departments. The specific categories of resources being sought from respondents are as follows:

- 2.1.1 BILLBOARDS
- 2.1.2 POSTERS
- 2.1.3 MOVIE THEATER SLIDE SHOW PRESENTATION
- 2.1.4 RADIO COMMERCIALS
- 2.1.5 PUBLIC BUS ADVERTISEMENT
- 2.1.6 MALL KIOSK
- 2.1.7 OTHER VISUAL MEDIUMS

Respondents shall indicate on ATTACHMENT A each category of service they propose.

2.2 TASK ORDER PROCESS:

- 2.2.1 For any scope of work under this contract, the requesting County department shall solicit a task order for the relevant category directly with the Vendors awarded that category.
- 2.2.2 The requesting department will communicate requirements to all qualified vendors. Vendors must provide pricing and relevant information to the requesting department and may suggest alternatives, if any.
- 2.2.3 The method of communication may be via telephone/e-mail / fax or other appropriate means. Responses to these task order solicitations shall be submitted directly to the requesting department. The department will then select a vendor using the following evaluation criteria:

2.2.3.1 Direct experience of vendor to accomplish the specific tasks, per their original submission and award.

2.2.3.2 Availability of advertisement spots, etc., to meet the needs of the project (including the duration of the project).

2.2.3.3 Compliance with specifications.

2.2.3.4 References for similar statement of work if requested.

2.2.3.5 Pricing

2.2.4 Upon selection of a vendor, the departments will contact the vendor for finalizing an agreement regarding the services to be performed, duration of assignment, etc.

2.2.5 A Purchase order will be issued to the lowest responsive vendor based on the quotes submitted. The Purchase Order will include the Cost Center to be charged, the name of the department contact person, job details, the expected time, place, and duration of the assignment, and the nature of the work to be performed. Vendors must not start any assignments without a Purchase Order (or in case of PCard, a written confirmation from the agency).

2.3 PRICING:

2.3.1 Pricing is not required to be submitted with this IFB.

2.3.2 Pricing/Quotations will be requested by using agency, on an as needed basis (see 2.2)

2.4 PAYMENT:

The contractor shall submit invoices no more frequently than once per week directly to each using agency. Each invoice shall include sufficient detail to justify payment. The agency shall process the claim for prompt payment.

3.0 SPECIAL TERMS & CONDITIONS:

3.1 CONTRACT LENGTH:

This Invitation for Bids is for awarding a contract to cover a ten (10) year period.

3.2 INDEMNIFICATION AND INSURANCE:

3.2.1 Indemnification.

To the fullest extent permitted by law, Contractor shall defend, indemnify, and hold harmless the County, its agents, representatives, officers, directors, officials, and employees from and against all claims, damages, losses and expenses, including but not limited to attorney fees and costs, relating to this Contract.

The amount and type of insurance coverage requirements set forth herein will in no way be construed as limiting the scope of the indemnity in this paragraph.

The scope of this indemnification does not extend to the negligence of the County.

3.2.2 Insurance Requirements.

Contractor, at its own expense, shall purchase and maintain the herein stipulated minimum insurance with companies duly licensed, possessing a current A.M. Best, Inc. Rating of B++6, or approved unlicensed companies in the State of Arizona with policies and forms satisfactory to the County.

All insurance required herein shall be maintained in full force and effect until all work or service required to be performed under the terms of the Contract is satisfactorily completed and formally accepted. Failure to do so may, at the sole discretion of the County, constitute a material breach of this Contract.

The Contractor's insurance shall be primary insurance as respects the County, and any insurance or self-insurance maintained by the County shall not contribute to it.

Any failure to comply with the claim reporting provisions of the insurance policies or any breach of an insurance policy warranty shall not affect coverage afforded under the insurance policies to protect the County.

The Contractor shall be solely responsible for the deductible and/or self-insured retention and the County, at its option, may require the Contractor to secure payment of such deductibles or self-insured retentions by a surety bond or an irrevocable and unconditional letter of credit.

The County reserves the right to request and to receive, within ten (10) working days, certified copies of any or all of the herein required insurance policies and/or endorsements. The County shall not be obligated, however, to review such policies and/or endorsements or to advise Contractor of any deficiencies in such policies and endorsements, and such receipt shall not relieve Contractor from, or be deemed a waiver of the County's right to insist on strict fulfillment of Contractor's obligations under this Contract.

The insurance policies required by this Contract, except Workers' Compensation, shall name the County, its agents, representatives, officers, directors, officials and employees as Additional Insureds.

The insurance policies required hereunder, except Workers' Compensation, shall contain a waiver of transfer of rights of recovery (subrogation) against the County, its agents, representatives, officers, directors, officials and employees for any claims arising out of Contractor's work or service.

3.2.2.1 Commercial General Liability. Contractor shall maintain Commercial General Liability insurance with a limit of not less than \$1,000,000 for each occurrence with a \$2,000,000 Products/Completed Operations Aggregate and a \$2,000,000 General Aggregate Limit. The policy shall include coverage for bodily injury, broad form property damage, personal injury, products and completed operations and blanket contractual coverage including, but not limited to, the liability assumed under the indemnification provisions of this Contract which coverage will be at least as broad as Insurance Service Office, Inc. Policy Form CG 00 01 10 93 or any replacements thereof.

The policy shall contain a severability of interest provision, and shall not contain a sunset provision or commutation clause, or any provision which would serve to limit third party action over claims.

The Commercial General Liability additional insured endorsement shall be at least as broad as the Insurance Service Office, Inc.'s Additional Insured, Form CG 20 10 11 85, and shall include coverage for Contractor's operations and products and completed operations.

If the Contractor subcontracts any part of the work, services or operations awarded to the Contractor, Contractor shall purchase and maintain, at all times during prosecution of the work, services or operations under this Contract, an Owner's and Contractor's Protective Liability insurance policy for bodily injury and property damage, including death, which may arise in the performance of the Contractor's work, service or operations under this Contract. Coverage shall be on an occurrence basis with a limit not less than \$1,000,000 per occurrence, and the policy shall be issued by the same insurance company that issues the Contractor's Commercial General Liability insurance.

3.2.3 Certificates of Insurance.

3.2.3.1 Prior to commencing work or services under this Contract, Contractor shall have insurance in effect as required by the Contract in the form provided by the County, issued by Contractor's insurer(s), as evidence that policies providing the required coverage, conditions and limits required by this Contract are in full force and effect. Such certificates shall be made available to the County upon 48 hours notice. **BY SIGNING THE AGREEMENT PAGE THE CONTRACTOR AGREES TO THIS REQUIREMENT AND FAILURE TO MEET THIS REQUIREMENT WILL RESULT IN CANCELLATION OF CONTRACT.**

If a policy does expire during the life of the Contract, a renewal certificate must be sent to the County fifteen (15) days prior to the expiration date.

3.2.4 Occurrence Basis.

All insurance required by this contract shall be written on an occurrence basis rather than a claims-made basis.

3.2.5 Cancellation and Expiration Notice.

Insurance required herein shall not be permitted to expire, be canceled, or materially changed without thirty (30) days prior written notice to the County.

3.3 PROCUREMENT CARD ORDERING CAPABILITY:

It is the intent of Maricopa County to utilize a procurement card that may be used by the County from time to time, to place and make payment for orders under the Contract. Contractors without this capability may be considered non-responsive and not eligible for award consideration.

3.4 INTERNET ORDERING CAPABILITY:

It is the intent of Maricopa County to utilize the Internet to place orders under this Contract. Contractors without this capability may be considered non-responsive and not eligible for award consideration.

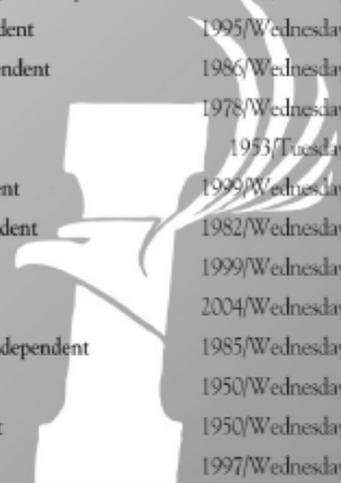

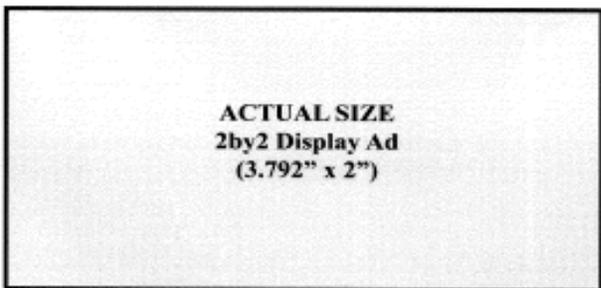

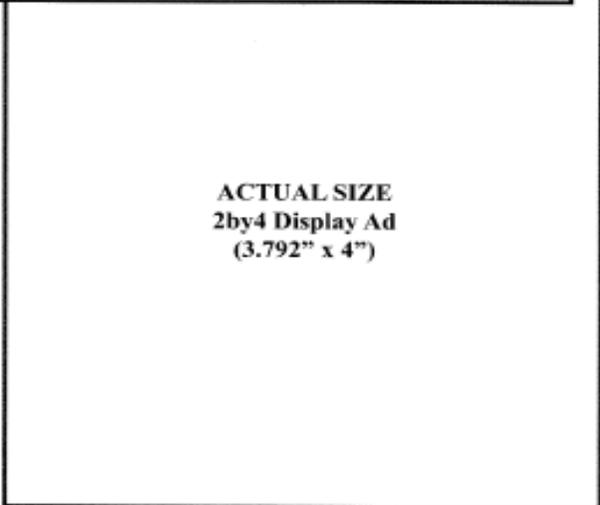
