Request: Text Amendment FCD 2014-001 to the Floodplain Regulations of Maricopa County, revising the limitations on floodplain management delegations to reduce a regulatory burden.

Discussion: The proposed text amendment authorizes the Chief Engineer & General Manager to delegate floodplain management responsibilities to Maricopa County staff or other individuals who are not employees of the Flood Control District. The Floodplain Regulations currently refer only to District staff performing delegated floodplain management responsibilities.

Previous Board Actions: The Board of Directors approved the current version of the Floodplain Regulations of Maricopa County under resolution FCD 2011R005 on November 30, 2011 (C-69-12-018-7-00).

A text amendment regarding the appeals process was approved on April 9, 2014 (C-69-14-026-M-00).

On May 7, 2014, the Board of Directors took action to set a public hearing for June 25, 2014 to solicit comments and consider the adoption and enforcement of the proposed Text Amendment 2014-001, and to publish a public notice thirty days prior to the public hearing (C-69-14-039-M-00).

Staff Recommendation: Approve

Flood Control Advisory Board Action: April 23, 2014: Approve (6-0) staff's recommendation to initiate a change to the Floodplain Regulations for Maricopa County, to recommend advancing Text Amendment FCD 2014-001 under the expedited enhanced regulatory outreach process, and to recommend to the Board of Directors approval of Text Amendment FCD 2014-001.

Advisory Board Discussion

Notes:

Staff reviewed the proposed amendment, identifying text within the Floodplain Regulations that would be modified to broaden the individuals to whom the Floodplain Administrator is authorized to delegate authority. Mr. Justice inquired as to the impetus for the proposed change. Staff reported that the change is consistent with a recommendation identified by a Maricopa County Planning & Development ad hoc citizen's committee, transferring unincorporated county floodplain use permitting staff to Planning & Development's One Stop Shop. It was moved by Mr. Martin and seconded by Mr. Dovalina to approve staff's recommendation. The motion carried unanimously.

Public Meeting Dates:

An initial stakeholder meeting was held on April 2, 2014. Four external stakeholders attended. A Flood Control Advisory Board meeting was held on April 23, 2014 with nine attendees.

Public Support/Opposition:

No comments of support or opposition have been received.

Other Public Agency Involvement:

Invitations to the stakeholder meeting were sent to representatives of all cities and towns in Maricopa County, and various federal and state agencies. No other public agencies attended, with the exception of Maricopa County Planning & Development staff. Floodplain management delegations to Maricopa County staff are being coordinated with Planning & Development.

Proposed Amendment

Floodplain Regulations for Maricopa County Proposed Text Amendment FCD 2014-001

Paragraph A of Section 201, Designation of the Floodplain Administrator, is amended to read as follows:

The Floodplain Administrator as designated by the Board of Directors shall be the Chief Engineer and General Manager of the District who shall administer and enforce these Regulations. The Floodplain Administrator may delegate signature authority ~~to District staff~~ for permitting purposes.

Paragraph B (2) of Section 201, Substantial Improvement and Substantial Damage Procedures, is amended to read as follows:

- a. Develop detailed procedures for identifying and administering requirements for substantial improvement and substantial damage, to include defining "Market Value."
- b. Assure procedures are coordinated with other departments and divisions and implemented by District assigned staff.

The first paragraph of Section 202, Duties of Communities Dependent on the District, is amended to read as follows:

Communities in Maricopa County that have elected not to assume floodplain management responsibility as authorized in A.R.S. §48-3610 shall appoint a Community Floodplain Administrator who will be responsible for 1) coordinating with ~~District staff~~ the District Floodplain Administrator's designee in providing floodplain management responsibility, and 2) verifying that the Community's participation in the National Flood Insurance Program is maintained and remains in good standing through adoption and enforcement of these Regulations.

Paragraph C of Section 404, Permit Conditions, is amended to read as follows:

Permit Inspections are required as part of a Floodplain Use Permit and will be conducted in accordance with all statutory requirements.

1. All permitted work shall be inspected in accordance with the specific requirements of the permit stipulations in addition to any in-progress or follow up inspections as may be deemed necessary by the applicant and District-designated inspection staff during the course of construction.
2. Sites permitted for the extraction of sand and gravel or other materials shall be inspected every six (6) months to verify that the plan of development is followed and no violations of these Regulations, applicable laws, or permit conditions exist.

3. Re-inspection of sites permitted for the extraction of sand and gravel or other materials shall be conducted within thirty (30) days after the date set forth in the notice of violation to verify the correction of an alleged violation, or for cease and desist order, within ten (10) days after the notice of violation is served.

Paragraph A of Section 405, Elevation and Floodproofing Certificates, is amended to read as follows:

After obtaining a Floodplain Use Permit and prior to Final Inspection, a complete, correct, and current FEMA Elevation Certificate form prepared by an Arizona Registered Professional Engineer or Land Surveyor shall be submitted to the Floodplain Administrator prior to occupancy or use of any building within a Special Flood Hazard Area designated on the Flood Management Maps, except those uses exempted by applicable law. The [authority to complete the](#) required elevation certificate within a Zone AO may be ~~completed by District staff as approved~~ [delegated](#) by the Floodplain Administrator.

Paragraph A of Section 707, Hearing Procedures, is amended to read as follows:

A. Parties

1. The owner or alleged violator and the District representative must appear before the Hearing Officer on the date, time and place designated for adjudication of the alleged violation.
2. An owner or alleged violator may be represented by an attorney or other designated representative. The District may be represented by the county attorney or by other counsel for the District, [or by a non-counsel representative](#) ~~or may be represented by District staff~~ if the alleged violator is appearing without counsel.
3. If a party desires to be represented by counsel or a designated representative at the hearing, that party must provide written notice of such representation to the Hearing Officer and opposing party a minimum of 24 hours before the scheduled date and time of the hearing. Representation by counsel may not be permitted at the hearing unless proof of notification is produced at the hearing.




Expedited Flood Control District Fee Schedule/Regulation Modification Procedure

3. If a party desires to be represented by counsel or a designated representative at the hearing, that party must provide written notice of such representation to the Hearing Officer and opposing party a minimum of 24 hours before the scheduled date and time of the hearing. Representation by counsel may not be permitted at the hearing unless proof of notification is produced at the hearing.

Scott Ward called the meeting of the Flood Control Advisory Board (FCAB) to order at 2:00 p.m. on Wednesday, April 23, 2014.

7) **FLOODPLAIN REGULATIONS FOR MARICOPA COUNTY TEXT AMENDMENT FCE 2014-001, FLOODPLAIN MANAGEMENT DELEGATIONS**

Presented by Kelli Sertich, Floodplain Management & Services Division Manager

STAFF RECOMMENDS THE FOLLOWING ACTION: (1) Initiate a change to the Floodplain Regulations for Maricopa County. In the event of no public opposition, additionally, (2) recommend advancing Text Amendment FCD 2014-001 under the expedited enhanced regulatory outreach process and (3) recommend to the Board of Directors approval of Text Amendment FCD 2014-001.

Board Member Ward asked Ms. Sertich to begin by introducing herself, to confirm whether she was the floodplain manager for Maricopa County and how this affects FEMA. Ms. Sertich stated she is the Floodplain Management and Services Division Manager and that Mr. Phillips is the Floodplain Administrator for Maricopa County, as recognized by FEMA.

Text amendments to the floodplain regulations have been generated from response to a task force on regulatory review that Planning and Development went through last fall. The amendments are administrative in nature and do not add regulatory burden or changes to the requirements. The text amendments have proceeded through the enhanced regulatory outreach process through the expedited program. The stakeholder meeting was held on April 2nd. The stakeholder meeting was noticed on the outreach website. In addition, the information was sent out to the 24 communities in Maricopa County as well as relevant federal agencies and other organizations, such as the Homebuilders Association and others. Six individuals attended the stakeholder

meeting. Ms. Sertich then reviewed the minor text changes. She added that additional information can be found at the regulatory outreach website.

Board Member Justice asked about what precipitated the need for outside input. Mr. Phillips stated all the regulatory departments are being asked to have ad hoc committees of citizens groups, those who use the services, to review things that can be improved. One of the recommendations that was approved by the Board including having Maricopa County being the one stop shop as the sole place to obtain a permit. The effect of this for the District was to transfer the permitting process for the unincorporated county to Planning and Development staff.

Mr. Phillips further clarified that Advisory Board is being asked to endorse the expedited process with the understanding that there has been no opposition from the stakeholders meeting or at the present meeting, therefore justifying their endorsement of the expedited process.

ACTION: It was moved by Board Member Martin and seconded by Board Member Dovalina to initiate a change to the Floodplain Regulations for Maricopa County, to recommend advancing Text Amendment FCD 2014-001 under the expedited enhanced regulatory outreach process and to recommend to the Board of Directors approval of Text Amendment FCD 2014-001. The motion carried unanimously.

The meeting adjourned at 2:55 p.m.

The meeting commenced at 10:05 am. District staff initiated the meeting with a welcome and introductions from all attendees. The stated meeting purpose was to review with stakeholders a proposed text amendment to the Floodplain Regulations for Maricopa County, authorizing the Chief Engineer & General Manager to delegate floodplain management responsibilities to others who are not employees of the Flood Control District.

District staff provided a walkthrough of the County's Enhanced Regulatory Outreach Program website. Staff walked through the proposed text amendment, reviewing the six areas where text amendment changes are proposed, and followed up with an open discussion.

One attendee had questions about the process that they underwent in trying to obtain an Elevation Certificate. The attendee was asked to meet with District staff following the stakeholder meeting to obtain the necessary information.

Another attendee came to the stakeholder meeting anticipating discussion of Section 409 (Appeals) that was addressed during the October 24, 2013 Stakeholder Meeting addressing Text Amendment FCD 2013-001. The attendee was informed that Section 409 was not impacted by the proposed amendment 2014-001, and that the amendment impacting Section 409 is scheduled for the Board Meeting on April 9th.

The meeting was opened for comments and questions. No opposition was indicated to the proposed text amendment. Attendees were informed that the next step would be presentation of the proposed text amendment to the Flood Control Advisory Board on April 23rd.

The meeting adjourned at approximately 10:24 am.



Subject: Text Amendment FCD 2014-001 to Floodplain Regulations for Maricopa County

In accordance with the "Moratorium on Increased Regulatory Burdens" (C-44-13-104-M-00), the Flood Control District of Maricopa County requests your approval to pursue a text amendment to the Floodplain Regulations for Maricopa County (TA FCD 2014-001). Consistent with the moratorium, the amendment is proposed to lessen a regulatory burden.

Floodplain management is statutorily the responsibility of the Flood Control District, and the Board has designated the Chief Engineer & General Manager of the District as the Floodplain Administrator. The Floodplain Regulations authorize the Chief Engineer & General Manager to delegate authority to District staff and include other references to District staff. As the County works to enhance customer service by consolidating certain permitting functions under the One Stop Shop, these references in the Floodplain Regulations need to be broadened to recognize that floodplain permitting functions may be performed by District staff, County staff or, conceivably, consultant staff under authority granted by the Chief Engineer & General Manager.

Staff recommends advancing this text amendment through the Enhanced Regulatory Outreach Process.
